This is possible only when they completely trust that mediator will not act in any one's favour particularly & will work in the best interest of both the parties.

Neutrality:

The faith reposed by the parties in the mediator at time of his appointment needs to be maintained not only if the entire proceeding is over but also thereafter. This faith should not only exist but also seem to be existing all the time. A mediator should never give an impression that he is leaning in favour of any of the parties. This neutrality should get reflected not just inside the mediation room but also outside. It is the neutrality, which re-inforces trust.

c) Confidentiality:

The parties to the dispute approach the mediator with the hope that what ever would come to the knowledge of mediator during the proceedings will remain with him only. Sometimes the disputes on the face of it look to be entirely different from what they actually are. The parties divulge a lot of personal details to the mediator in confidence that they will not be shared with not just the other party but also with no one else.

d) Listen patiently:

When the parties walk into mediation they carry a lot of emotional baggage. They look for an opportunity that someone hears them. Once a party goes with a feeling that he has been heard to his satisfaction, a mediator may

MEDIATION

Meaning of mediation.

Mediation is a form of alternative dispute resolution, a way of resolving disputes between two or more parties with concrete effects.

Typically, a third party, the mediator, assists the parties to negotiate a settlement. Disputants may mediate disputes in a variety of domains, such as commercial, legal, diplomatic, workplace, community and family matters.

The process is private and confidential, possibly enforced by law. Mediation can be used to resolve disputes of any magnitude.

Qualities of mediator.

There are a few basic qualities which every mediator should possess. They are:

a) Trust:

One can work as a mediator so long as he or she enjoys the trust of the parties. The parties can pick a mediator only when they have a trust in the mediator or they have a reason to believe that they can trust him. The reason for it is simple. Although more often than not a mediator follows a structured process for resolving the dispute but he or she does not maintain any formal record of what transpires in the proceedings. The parties communicate to the mediator in confidence that their secrets will not be revealed to others unless he or she himself or herself so desires.

f) Do not try to grab all the credit

A mediator may be chief architect of the final settlement between the parties but still he should not take all the credit for it.

g) Punctuality

Unlike the regular courts, it is not that hard to stick to schedule framed for mediation. Discourage the postponement of the matter unless it is necessary for finding the solution itself.

h) Act within four corners of law

Mediation proceedings have the sanctity of law. It gives a mediator the freedom to adopt procedure of his own to resolve the dispute between the parties. A mediator should never lose sight of the fact that the settlement arrived before him can be challenged if it is patently against the law or the public policy or he adopted ^{Principal} the procedure which

no reasonable person would even undertake.

f) Knowledgeable:

Once negotiation is over a mediator is required to help the parties draw the terms of settlement. These settlements should be such that they would not fall apart once they are tested on the touchstone of law. This can only be achieved if the mediator has the knowledge of the subject matter of the dispute & the law related to it.

g) Optimism:

Mediation proceeds on the realistic assessment of the situations. Then a mediator should be a realist not an optimist. In the general sense of the word optimism would mean giving hope for a solution even where the chances of its success are very dim.

3. Role of a mediator:

- The mediator's primary role is to act as a neutral third party who facilitates discussions between the parties.
- In addition, a mediator serves in an evaluative role when they analyse, assess the issues, and engage in reality-testing.
- A mediator is neutral if they are not the agent of any party.
- Mediators also manage the interaction between the parties and encourage constructive communication through the use of specialized communication techniques.
- The mediator should restrict pressure, aggression and intimidation, demonstrate how to communicate through employing good speaking and listening skills, and paying attention to non-verbal messages & principal signals emanating from the content.

Unlike the regular courts, it is not that hard to stick to schedule framed for mediation. Discourage the postponement of the matter unless it is necessary for finding the solution itself.

h) Act within four corners of law.

Mediation proceedings have the sanctity of law. It gives a mediator the freedom to adopt procedure of his own to resolve the dispute between the parties. A mediator should never lose sight of the fact that the settlement arrived before him can be challenged if it is patently against the law or the public policy or he adopted ^{Principal} ~~the~~ procedure which

no reasonable person would even undertake.

f) Knowledgeable:

Once negotiation is over a mediator is required to help the parties draw the terms of settlement. These settlements should be such that they would not fall apart once they are tested on the touchstone of law. This can only be achieved if the mediator has the knowledge of the subject matter of the dispute & the law related to it.

g) Optimism:

Mediation proceeds on the realistic assessment of the situations. Then a mediator should be a realist not an optimist. In the general sense of the word optimism would mean giving hope for a solution even where the chances of its success are very dim.

3. Role of a mediator:

- The mediator's primary role is to act as a neutral third party who facilitates discussions between the parties.
- In addition, a mediator serves in an evaluative role when they analyse, assess the issues, and engage in reality-testing.
- A mediator is neutral & they are not the agent of any party.
- Mediators also manage the interaction between the parties and encourage constructive communication through the use of specialized communication techniques.
- The mediator should restrict pressure, aggression and intimidation, demonstrate how to communicate through employing good speaking and listening skills, and paying attention to non-verbal messages & ~~verbal~~ signals emanating from the content.

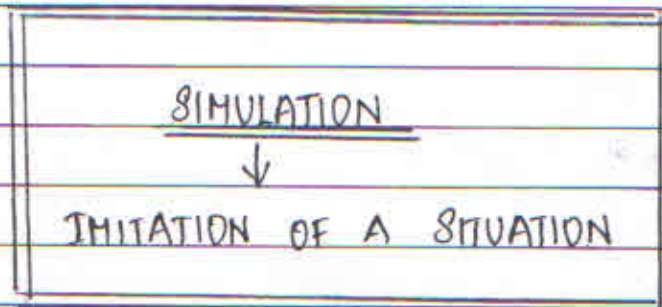

Brief facts of the case are that the Respondent paid a sum of ₹10,000/- on 16-5-1981 and ₹6,000/- on 4-10-1981 to Rao and Raju Builders Pvt. Ltd., Hyderabad. This amount was paid to construct a three bed room house on the plot allotted to the complainant.

As the said Builders failed to construct the house, the respondent met P.S. Rao Managing Director of Rao and Raju Builders Pvt. Ltd. to settle the matter amicably. The said P.S. Rao suggested to the respondent to approach the appellant A practicing Advocate at Hyderabad to seek his advice. The Respondent met him in March, 1984 and then appellant advised him to file a suit for recovery of amount from M/S Rao and Raju Builders Pvt. Ltd. The Respondent paid ₹5,000/- to the appellant for filing the said recovery suit and the appellant obtained his signatures on the plaint prepared by him. That thereafter the Respondent asked his brother-in-law to pursue the matter who was also G.P.A holder of the Respondent. The Respondent's brother-in-law met the appellant in July, 1991 and enquired about the case. The Respondent told him that it was still at S.R. stage and yet to be numbered. The Respondent on 4th September, 1991 sent a Regd. letter along with a draft of ₹400/- to the appellant for taking necessary steps so that the matter maybe taken up before the City Civil Court, Hyderabad. The appellant did not send any reply and another Regd. letter was sent to him on 12-12-1991 since no reply was also sent by the appellant, the Respondent filed a case against the appellant for professional misconduct as he failed to file the suit of

the Respondent inspite of having received the amount of fee.

On the complaint of the Respondent the appellant was issued show cause notice and the appellant submitted his reply wherein he admitted the fact that the Respondent had approached him for consultation but in view of the fact that the appellant was approached by Mr. P.S Rao one of Directors of Rao and Raju Builders Pvt. Ltd., expressed his inability to prosecute the matter and gave friendly advice for instituting a case against the firm. Rest of the allegations have been denied. He returned the same on 19-9-1991 and he never encashed the said draft of ₹400/- The Appellant, therefore, did not accept the brief of the Respondent and as such he was not guilty of any professional misconduct.

On the pleadings of the parties following issues were framed :

1. Whether it is a fact that the Complainant paid a sum of Rs. 500/- to the Respondent to file a suit to recover the amounts due to him from Rao and Raju Builders, Secid, Hyderabad?

2. Whether the Complainant sent a D.D. for Rs 400/- again by Regd post on 4-9-1991 to the Respondent asking him to take all steps necessary for the case entrusted by him?

3. Whether the Respondent took any steps in respect of the case entrusted by the Complainant to him?
