1. MC read and recorded the proceedings of the last Governing Council meeting held on 01.02.2017. MC with reference to Item No. 2, wherein it was mentioned that the Principal has to encourage other teaching faculty to attend Seminars, workshops in their specialized areas, the Principal informed that the advisory decision is being implemented and invited the members for a colloquium on 15th June 2017 at 10.30 a.m. where the teachers would make a presentation on their respective papers which they have presented in various National/State Level seminars.
