The use of technology or machines may increase productivity risks resulting in increased social inequality by lowering wages and loss of jobs. New technologies have changed the landscape of the nature of the work by increasing efficiency, while affecting the livelihood of many. She said that there is a fear of abuse of data collected and breach of the right to privacy.

Madam ended her lecture by sharing her apprehensions on the impact to high technology on Human Rights. **REPORT ON LATE SMT. K. KAMALAMMA AND LATE SRI. A.C. APPAREDDY
MEMORIAL LECTURE:**

Hon'ble Justice Gopala Gowda, Former Judge of Supreme Court of India, spoke on the subject 'Doctrine of Eminent Domain' it means the supreme power of the king or the government under which the property of any person can be taken over in the interest of the general public. However over the years such taking over of property by the king or the government has been made possible only after compensating the land holder or owner of such property. This doctrine based on two maxims namely 'SALUS POPULI EST SUPREMA LEX' and 'NECESSITA PUBLIC MAJOR EST QUAM' which means welfare of the people is the paramount law and public necessity is greater than the private necessity. The term 'eminent domain' is a derivative of the Latin term 'dominium eminens' which means the 'supreme lordship'. it was used in the 17th Century by Hugo Grotius' who was said to be the originator of the term 'Eminent Domain', in his book 'De Jure-Belli Et Pacis'. In India Constitution is the supreme law of India. It frames fundamental political principles, procedures, practices, rights, powers and duties of the government.

The Constitution of India guaranteed to all citizens the right to acquire, hold and dispose of property under Article-19(1)(f). under Article 19(5), state is empowered to impose by law reasonable restrictions on that right in the interest of general public or for the protection of the interest of any Scheduled Tribe. The provision of Article-19(1)(f) was repealed by 44th amendment act-1978, for a variety of reasons with effect from 20/06/1979, therefore any law enacted prior to this date shall be open to challenge on the ground of contravention of the fundamental right under Article-19(1)(f). It inserted a new provision namely Article-300A. Various other Articles also inserted such as Article-31-A, provides for saving of laws providing for acquisition of estates, Article-31-B, provides for validation of certain acts and regulations and Article-31-C, provides for saving of laws giving effect to certain directive principles. It provides that 'no person shall be deprived of his property save by authority of law. It means the deprivation of property must be 'just, fair and reasonable. The amendment safeguarded that the right to property is no more a fundamental right but somewhat a constitutional or legal right or statutory right and in the event of violation, the remedy obtainable to an affected person is through the High Court under Article-226 of the Indian Constitution.
