

To become an advocate and practice law in India, individuals must enrol with the local State Central Bar Council and adhere to the codes and regulations set by the Bar Council of India and State Bar Councils.

Apart from practicing law, there are various career opportunities for law graduates. Government services provide positions such as law officers, assistant advisors, deputy legal advisors, and legal advisors through the Union Public Service Commission (UPSC). State legal services also appoint lawyers through State Public Service Commission (SPSC) exams for senior positions in the state police, revenue, and judicial departments. Additionally, there are opportunities in the judiciary, such as magistrates, district and session judges, public prosecutors, solicitors, attorneys general, advocate generals, notaries, and oath commissioners. Law graduates can also work as legal secretaries, law inspectors, legal officers in banks, judicial members of income tax, sales tax, and excise departments, government advocates, and staff in the registrar of companies offices.
