Under this Convention, State Parties are required to take appropriate measures to eliminate any discrimination against women in the workplace & to promote equality with men in the field of employment. Hence, in pursuance of UGC (Prevention, Prohibition & Redressal of Sexual Harassment of Women Employees & Students in Higher Educational Institutions) Regulations, 2015, read with Sexual Harassment of Women at Workplace (Prevention, Prohibition & Redressal), Act, 2013, the institution has constituted the Internal Complaints Committee, as prescribed under Sec. 4 of the Act with the following Aims & Objectives.

Aims:

- 1. To give effect to women's economic independence.
- 2. To prevent gender bias in general & sexual harassment in particular, at work place.
- To bring women within the sphere of economic empowerment & achieve the goal of inclusive growth.
- 4. To create a conducive working environment for women, as prescribed under the Act.
- To promote women's right to practice any profession or to carry on any occupation, trade or business under Art.19 of the Constitution of India.

Vivekananda College of Law has a zero-tolerance towards any act of ragging. Ragging in any form is banned inside and outside the campus. Ragging in any form is totally prohibited in the College. Strict action will be taken against persons flouting this rule; no leniency will be shown.

The college has a well-established Anti-Ragging Cell. This cell is formed in accordance with the regulations of the UGC.

The Cell's responsibility is to ensure that students maintain discipline in the classrooms and within the college campus. Members of the cell regularly go on rounds to each and every classroom to make note of delinquent behaviour and to make sure that the college campus is free from ragging and eve-teasing. The Cell takes severe punitive action against students indulging in such atrocious activities.

Aims & Objectives:

- To prevent any physical or mental torture or any disorderly conduct towards any student causing apprehension, dread, humiliation, or agitation in him or her.
- To aware the students of the dehumanizing effect of ragging inherent in its perversity.

To maintain a ragging free campus.

UGC Regulations on curbing the menace of Ragging. "SAY NO TO RAGGING"

As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), Ragging constitutes one or more of any intention by any student or group of students on:

- 1. Any act of Indiscipline, Teasing or Handling with Rudeness.
- 2. Any act that Prevents, Disrupts the Regular Academic Activity.
- 3. Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
- 4. Any Act of Financial Extortion or Forceful Expenditure.
- 5. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
- 6. Any Act of abuse by spoken words, emails, SMS or public insult etc.
- 7. Any Act of injury or infringement of the fundamental right to the human dignity.
- Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
- 9. Any unlawful assembly or conspiracy to ragging.

Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments

- 1. Debarring from appearing in any Internal test / University Examination
- 2. Suspension from attending classes and academic privileges
- 3. Withdrawing scholarships and other benefits
- 4. Suspension from the college
- 5. Cancellation of the admission


