Proceedings of the Governing Council Meeting held on 11.08.2017 at 10.30 a.m. in Vivekananda College of Law, Maruthi Extension, Gayathrinagar, Bangalore under the Chairmanship of Prof. G K Narayana Reddy, President, Janatha Education Society.

Sri.C N Manchegowda, Secretary, JES and Dr.A C Raghuram, expressed their inability to attend the meeting due to personal reasons and sought leave of absence.

The meeting commenced with welcome proposed by Prof. G K Narayana Reddy, Chairman of the Governing Council.

1. Reading and Recording the proceedings of the last Governing Council meeting held on 14.06.2017	Members appreciated the colloquium system adopted in the Law College. While reviewing the proceeding of the previous Governing Council meeting regarding the colloquium, the president advised teachers to present a paper in colloquium before presenting it in conferences/Seminars/Workshops which will enable both the researchers and teachers to collectively contribute to augment knowledge and improve the academic environment. Further the members appreciated the Principal for convening the Governing Council

	Meeting within 2 months from the previous meeting. Further, commenting on compliance/action taken on the decisions of the G C, they insisted that the principal has to comply with the decisions of the previous meeting expeditiously.
2.To consider the budget estimates for the academic year 2018-19	After detailed discussion and suggestions by the members the proposed budget was unanimously approved.
3. Re-appointment of part time teachers w.e.f. 01.08.2017	It was unanimously resolved to reappoint 6 part time teachers for the academic year 2017-18 with effect from 01.08.2017. However, it was resolved in case of Sri.Rajesh Kumar, Part Time Lecturer to teach English the consolidated remuneration should be hiked to Rs.13,000/- in the light of difficulties experienced in finding suitable English teachers. 4. Renewal of lift Annual Maintenance contract with M/s. Kone Elevators	It was unanimously decided to renew AMC with M/s.Kone and sanctioned Rs.39,639/- subject to negotiation by the Chairman, Purchase Committee. Further the Chairman, Purchase Committee was given authorization to approve <del>the same,</del> for the negotiated amount.
5. Sanction of advance of Rs. 80,000/- to depute students to attend Moot Court Competitions for the -Academic Year	Sanctioned Rs.80,000/- after considering the expenditure of Rs.71,000/- incurred during the last academic year
6. To consider the salary increment which falls due in July / Aug 2017	Increments were sanctioned as per the list enclosed
7. Interaction with the staff	It was decided to have interaction with the concerned staff members within a week.
8.Any other subject with the approval of the chair	1. The proposal submitted by Sri.B V Umesh, regarding providing wi-fi facility in the campus for Rs.80,000/- was sanctioned as per the

proposal. Further, it was resolved to invite quotations from reputed firms and to pursue the work after due negotiations by the chairman Purchase Committee.

2. It was resolved to call for quotations towards typing and Bar code label printing and pasting for library automation and also for the purchase of Bar code printer and Bar code scanner for regular use in the library. The G C in its previous meeting sanctioned Rs.90,000 and Rs.32,000 respectively for this purpose.

Further it was resolved to negotiate with the firms and to entrust the same to the lowest bidder. Further, to oversee the library automation, Sri.Vijay Kumar Librarian, VKIT was approved to be invited by the principal as and when required for due supervision.

3. The Principal requested the members to permit him to make use of the services of Kum.Geetha Shindhe, practicing Advocate and an experienced mooter to train students to research, prepare memorials and for oral arguments for effective participation in various National Level Moot Court Competitions for this A Y. The remuneration for the same was approved to be sanctioned after receiving a recommendation in this regard by the principal after appraising her work. The Vice Principal was informed to <sup>coordinate</sup> ~~monitor the same~~ and report ~~and to co-ordinate~~ <sup>on</sup> in the training imparted.

4. The Principal brought to the notice of the members, the representations given by the students of both boys and girls hostel

expressing difficulties faced by them, regarding increase of rent and monthly mess bill and also payment of Rs.55,000/- in a single instalment. Members explored various options like providing only lodging facility/ creating perfect system and permitting the students themselves to run the Mess and collecting the hostel/mess fee on monthly basis/permit payment on instalment basis. The president suggested the matter may be referred to the Hostel Committee to take appropriate decision at the earliest.

5. It was unanimously resolved to place repeat order on par with sister institutions to supply Smart Identity Cards.

6. The Principal informed the members that the KSLU has entrusted upon us the responsibility to organize two days Inter Collegiate Chess Competition for both boys & girls in the month of September, 2017 and the university is likely to sanction Rs.75,000/- for the same.

Further, the Principal requested the members to sanction Rs.1,27,000/- for organising two days chess competition and the same was approved as suggested by the Chairman, Sports and Cultural Committee.

The meeting ended with a vote of thanks proposed by the principal.

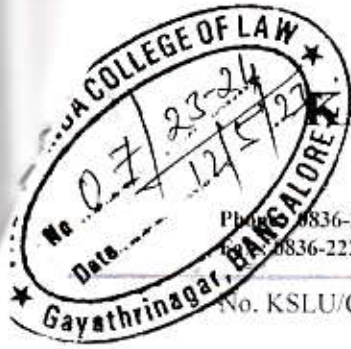
