



<p>1. The Governing Council perused the communication from the Joint Director, Collegiate Education regarding appointment of Sri. Venkatesh. V., FDA, Sri. Chikkahanumanthaiah, Attender and Sri. Kadirappa. D. C., Peon as per the recommendation of the SC/ST Commission and sought duty joining report of these employees in VCL for approval.</p> <p>In view of the above communication, it was resolved to transfer these employees from their respective institutions to VCL and informed the principal to send the information sought by the department along with their joining report to the duty after due approval by the M.C.</p> <p>2. The Governing Council noted the communication by BNSL regarding VPNOB connections provided in the NMAICT MHRD Project, under which 20 lines were provided by the BSNL with subsidized rate of Rs.1,290/- + taxes per year. In view of the option given to the institution either to retain all connections with Rs.4,500/- + tax per annum or to discontinue the same.</p> <p>The Principal appraised the members that out of 20 connections 9 are used in the college and 11 lines are provided to the faculty at their residence. As per the option given by the BSNL the concerned faculty has to exercise his/her option to retain or surrender the same.</p> <p>After due deliberations, it was resolved to retain 4 connections in the college and inform the principal to take appropriate action in the matter.</p> <p>3. The G.C. perused the communication of the Govt. of India, Ministry of MHRD and Higher Education dated 15.1.2018 regarding providing high speed internet access and Wi-Fi facility at free of cost to all Higher Education Institutions and informed the Principal not to proceed with the earlier decision for sanctioning of Rs.30,000/- to provide Wi-Fi facility in the campus and pursue with the concerned for getting free Wi-Fi facility.</p> <p>However, it was resolved to obtain a Static IP to enable staff and students to access SCC Online which is recently subscribed through upgrading the existing BSNL internet line and also to sanction Rs.3,000/- annual charges towards obtaining Static IP and approximately Rs.40,000/- p.a. towards internet broad band connection charges.</p>

Sri. I. Narayana Reddy, Joint Secretary, JES and Sri. A. M. Umashankar, Deputy Chairman, Building Committee, JES and Sri. Pradeep, Asst. Engineer informed the members that tender notification has already been notified and 18 th of April is the last date for filing of tenders after which comparative statement is to be prepared and submitted to the Building Committee for its approval. 2. Members urged the Building Committee to obtain information from structural engineer for construction of 3 class rooms as recommended in the previous Governing Council and approved by the Managing Committee. Further, the Principal was informed to submit detailed infrastructure requirements to JES at the earliest. 3. Sri.
