Vivekananda College of Law, Bengaluru organised an Online Lecture on 23rd July 2021 to sensitise the students of the institution on Gender Justice. On this occasion **Sister Jessi Kurian**, Advocate, Supreme Court of India and Alumna of V.C.L, Bengaluru spoke on the topic "**Home Maker and Notional Income**".

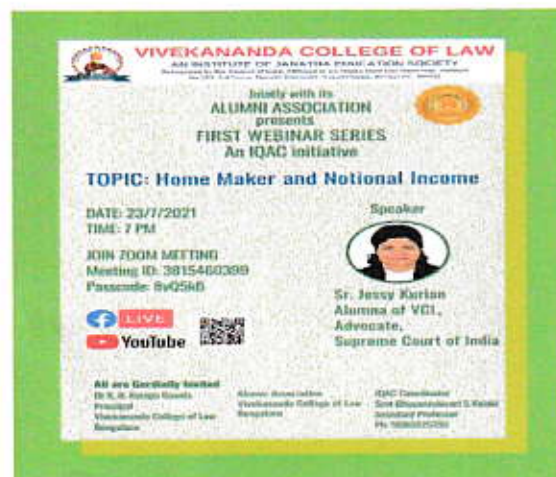
Sister Jessi Kurian started her address by stating that fixing notional income for home maker is a step towards equity and dignity of women which is our constitutional vision, in furtherance of our nation's obligation towards international law. In a significant ruling of Supreme Court has said that fixing notional income of homemakers in compensation to the society that the laws and the courts value their labours, services and scarifies.

In far reaching ramification especially in award of compensation to road accident victims involving home makers, the top court said that fixing of notional income is a recognition of the muttitude of women who are engaged in this activity, whether by choice or as a result of social or cultural norms.

Taking into consideration the gender nature of house work, with an overwhelming percentage of women being engaged in it as compared to men, the fixing of notional income for them attains special significance. It becomes recognition of work, labour and sacrifices of home makers and a reflection of changing attitude towards women's work.

On the question of how much notional income can be fixed, the bench said that various methods can be employed by the court to fix the notional income of a home maker, depending on the facts and circumstances of the case.

Prof. (Dr.) K.C.SUNNY, Vice Chancellor, National Institute of Legal Studies (NUALS) delivered the lecture on the topic '**STUDENT RIGHT TO DISSENT AND PROTEST**'. The Constitution of India under Article 19 bestows on its citizens the right to free speech and to assemble peacefully without arms. Hence to question, to challenge, to verify, and to ask for accountability from the government is the right of every citizen under the Constitution. These rights are inevitable for the existence of a vibrant democratic society and should never be taken away.

However the right to protest is not an explicit right but is derived from Article 19. The right to protest, like every other fundamental right is not absolute and is subject to reasonable restriction in the protection of state security, sovereignty, integrity, public order ethics, morality and so on.

The active use of the right to protest can help people to play the role of Watchdogs to continually monitor the actions of the government to ensure justice. These protests may be carried out to bring about positive social changes in various aspects of life, strengthen democracy, empower the vulnerable sections of society and increase accountability.

Protests however may sometimes be a public nuisance for people who do not share the same point or wish to get on with their everyday routines. Hence the right to protest may be curtailed if it infringes the rights of others, causing serious inconvenience for public.

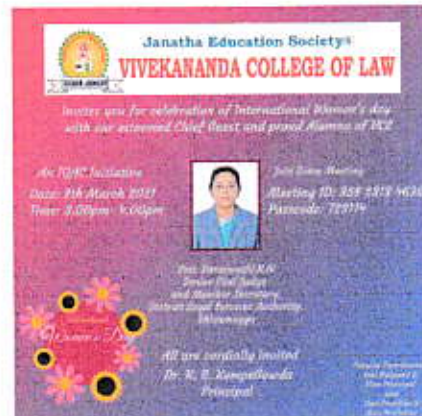

The development of the internet has widened access to knowledge, while new media platforms have given activities fast ways of organize communities and share messages at a large scale. The proponents argue that these technologies will create new opportunities, increase efficiency and help maximise human potential. However the flip side of it is the concern that rapid development in artificial intelligence, automation and robotics rise questions about the impacts on human rights and the future of work. The use of technology / machines may increase productivity risks resulting in increased social inequality by lowering wages and loss of jobs. New technologies have changed the landscape of the nature of work by increasing efficiency, while affecting the livelihood of many. Added to this is the fear of abuse of data collected and breach of the right to privacy, obliterating free and fair societies. She ended her lecture by sharing her apprehension on the impact of high technology on Human Rights. She cautioned care should be taken as to ensure that advanced technology should to all people and not marginalise any section of society.

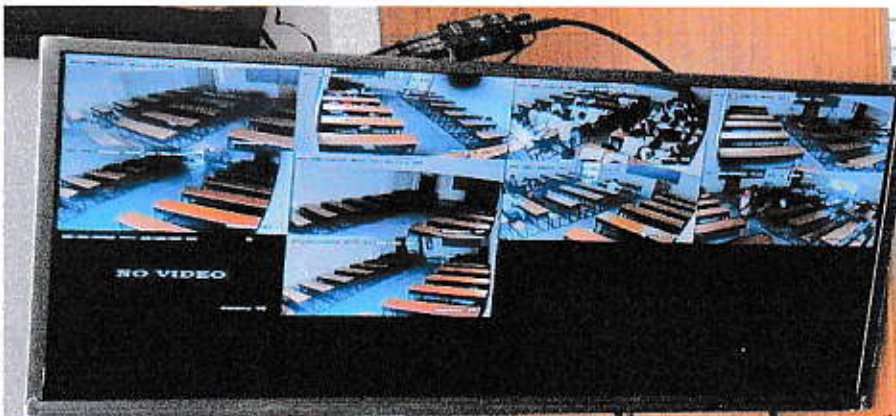

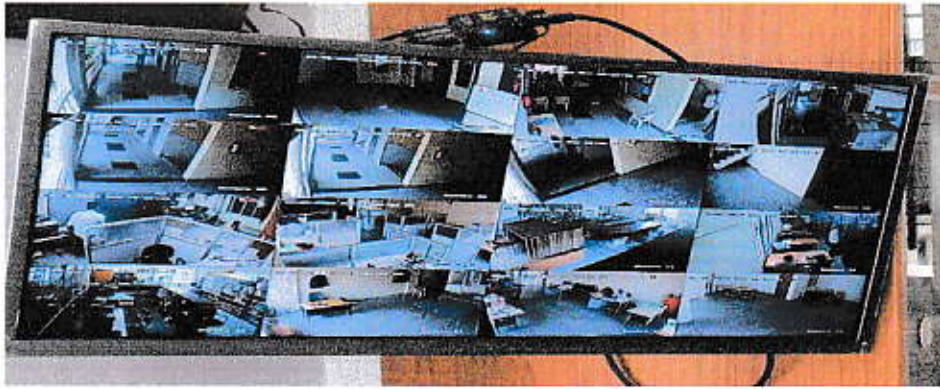
