



Title of the Best Practice: Law Forum, the platform of Vivekananda College of Law (VCL) for interaction between Law Agencies, Students & General Public

Objectives of the Practice:

The Law Forum is the platform constituted in Vivekananda College of Law for the conduct of various programmes to foster interaction between law agencies, students & general public. Law is a multi-disciplinary study regulating social life as a whole & so it is imperative to expose students to obtain firsthand experience on the functioning of law. Law is more than a set of abstract rules & hence there is a dire need to study 'law in action'. Law Forum provides avenues for experiencing the practical application of law. The focus of attention herein is on application of law to social realities of life through functioning of the Legal Aid Cell, & conduct of Legal Awareness, Literacy & Services Programmes.


The Context

Law is a Social phenomena. It is closely related with other social sciences. Law is the instrument for the adjustment of human conditions to the social forces operating in a given society. To cater to this need, Law Forum organises Guest Lectures from Legal Luminaries & experts from other related fields to enrich knowledge on the means available to reconcile conflicting interests in the society. Legal Awareness, Literacy & Services programmes are also arranged often by our college in other educational institutions & rural places through the Law Forum to educate the needy & general public on provisions available for legal assistance of which they are unaware, either due to their lack of legal knowledge or financial limitations. The Legal Aid Clinic provides free or low-cost legal services to clients who cannot afford them otherwise. Access to justice & legal empowerment are crucial for achieving inclusive & sustainable growth. Citizens, especially the vulnerable sections often face difficulties in addressing civil & administrative issues & procuring their entitlements. Law students can be of immense help in assisting them. Hence, the students are mentored to carry out survey in chosen villages to identify the legal needs & unmet entitlements of the inmates therein, devise legal measures to support their cause, approach concerned authorities & provide able assistance in having access to justice. This is the first step towards abiding by the rule of law & attempting to achieve equal justice for all.

Law students can create & spread awareness over various social issues through street plays & public rallies. Outreach campaigns are regularly organised by the institution under the aegis of Law Forum to spread awareness about environmental hazards during celebrations of some of our festivals viz., Deepawali, Ganesh Chaturthi. Consumer Rights awareness is regularly imparted. During Azadika Amruth Mahotsav, Har Ghar Tiranga celebrations our students visited houses in the vicinity to raise awareness on the legal need to lower the National Flag, hoisted on Independence Day, fold it as per the law & despatch it for onward transmission for safe disposal. These programmes generate interest, respect, enthusiasm, patriotism, & bonding in the community along with performance of Legal obligations.

Evidence of Success

The institution has a track record of conducting Legal Aid Awareness, Literacy & Services Programmes regularly in several nearby educational institutions for sensitising students on their basic human rights, consumer rights, right to information, gender justice & several other related rights. The Principal & faculty members address the students on the importance of health, hygiene, the ill-effects of smoking & addiction to consumption of alcohol or narcotic substances. The girl students are separately counselled to understand the distinction between good & bad touch. They are educated on the means of protecting themselves & others against sexual harassment.

The benefits of the programmes conducted by our institution are reaped by the students of Sarvagna Dheeksha P U College, Vijaynagar, VET College, J P Nagar, Mariyappa I Grade College, Rajajinagar, Corporation Girls P U College, Srirampuram, & R V College of Engineering, Bengaluru.

Legal Aid Camps have been held, surveys conducted & legal assistance given to the residents of Vijaypura, Devanahalli, through these programmes.

Problems Encountered & Resources Required

In the several Legal Awareness & Literacy Programmes conducted by the institution through Legal Aid Camps in nearby villages and rural areas, it has been observed that several people due to their illiteracy, poverty & lack of awareness, experience difficulties in procuring benefits under various Schemes of the Government to which they were legally entitled. To ensure that justice percolates to the last man, our Legal Aid Cell identify their issues & provides due assistance for redressal. The Guest Faculty members of the institution provide the necessary advice to the masses & guide law students to assist the people in their quest for realisation of those rights. However, increased awareness needs to be created among the masses in terms of procedures to be adopted for availing their entitlements. In this regard, the institution has done its best to coordinate with the Government Agencies at the State, District & Taluk levels for providing due benefits to the stakeholders. Such effort is also sustained with constant follow-up measures through the Legal Aid Clinic.
