Ref: Decision of the MC meeting dated 16-02-2017

1. MC read and reviewed and recorded the proceedings of the last GC meeting held on 10.11.2016.
2. MC while taking note of the activities from 29.10.2016 to till date directed the Principal, VCL to encourage other teaching faculty to attend Seminars / Workshops / Conference in their specialized areas.
3. MC while considering re-allocation of workload to part time teachers' w.e.f 01.02.2017 unanimously resolved to re-appoint the part time teaching faculty with remuneration mentioned against their names w.e.f 01.02.2017.
4. MC resolved to renew the list of Journals except "All England Law Reports" (4 volumes) from M/s Ashirvad Law Book. Suppliers and authorized the Chairman to negotiate with the supplier. "All England Law Reports" may be subscribed upon receipt of pricelist by the supplier.
