3. MC addressed the issue of classroom shortages by referring the matter to the Building Committee to explore the feasibility of constructing additional classrooms promptly.

Due to the classroom shortage, MC decided against expanding the 3-year LL.B Program by adding another section. Instead, they approved maintaining the current intake levels and authorized the necessary statutory payment to the Bar Council of India (BCI). This enables the Principal to apply for the continuation of existing programs to the BCI by the deadline of December 31, 2024, in accordance with BCI norms. Additionally, MC referred to the Building Committee the subject of extending the library's reading room. This expansion involves removing the existing wall and extending the reading room into the adjacent vacant space near the office room.

4. MC approved sanctioning yearly increments due to the grant-in-aid staff on VCL as in the list enclosed.
5. MC noted the reallocation the workload of part-time lecturers for even semesters w.e.f 29.04.2024 as per the list enclosed.
6. After perusing the UGC and the GoK guidelines regarding the constitution of a Committee under the Career Advancement Scheme, MC approved to permit the Principal VCL to communicate with the Department of Collegiate Education and the KSLU and to proceed further as per the norms.
7. MC approved to recommend the name of Sri Venkatesh V, SDA to the post of FDA under grant-in-aid to the GoK as per the communication received from the Department of Collegiate Education.
8. MC members expressed their appreciation for the invaluable service rendered by Smt. Rathna N. SDA and wished her a happy retired life.
9. MC took note of the stock report and the scarcity of chairs in the Auditorium and Moot Court hall due to an increase in the strength of the students and approved to accord permission to the Principal to purchase 100 chairs with arms with Nilkamal brand after following the purchase formalities.

10. MC decided to examine the request to sanction financial assistance of Rs.5,000/- per paper, per faculty member, per year for the publication of research papers in peer-reviewed journals, chapters in edited volumes/books, and papers in national/international conference proceedings, as currently provided to the faculty of VKIT.
11. MC decided to refer the subject matter of Sri Kumara M, Physical Education Director, VCL to enhance his salary with two increments so as to bring his salary on par with the teaching staff to the Pay Revision committee.
