### INTERNAL COMPLAINTS COMMITTEE

Working women face many obstacles in their work life, right from gender bias, low pay, and missed opportunities to sexual harassment. Since women are more vulnerable they are likely to be victims of sexual harassment. Sexual harassment leads to violation of the fundamental rights of a woman viz., right to equality, right to life and live with dignity and right to a safe working environment under Articles 14, 15, 21 and 19 respectively. Sexual Harassment results in insecure and hostile work environment, which discourages women's participation in work, thereby adversely affecting their social and economic empowerment and the goal of inclusive growth.


Hence, in pursuance of UGC (Prevention, Prohibition & Redressal of Sexual Harassment Women Employees & Students in Higher Educational Institutions) Regulations, 2015 read with Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 which was enacted with aim to provide protection against sexual harassment of women at workplace and for the prevention and redressal of complaints. Our Institution has constituted the Internal Complaints Committee, as prescribed under Sec. 4 of Act with following Aims and Objectives.

#### Aims

1. To give effect to women's economic independence.
2. To prevent gender bias in general and sexual harassment in particular.
3. To bring women within the sphere of economic empowerment and to attain the goal inclusive growth.
4. To create conducive working environment for women, as prescribed under the Act.
5. To promote women's right to practice any profession or to carry on any profession or any occupation or business.

#### Objectives

1. Prevention and Prohibition of Sexual harassment against the women employees and lady students.
