

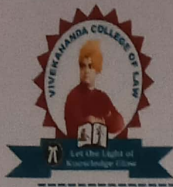


7.1.1 QIM Measures initiated by the Institution for the promotion of constitutional values and gender equity during the last five years.



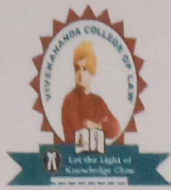

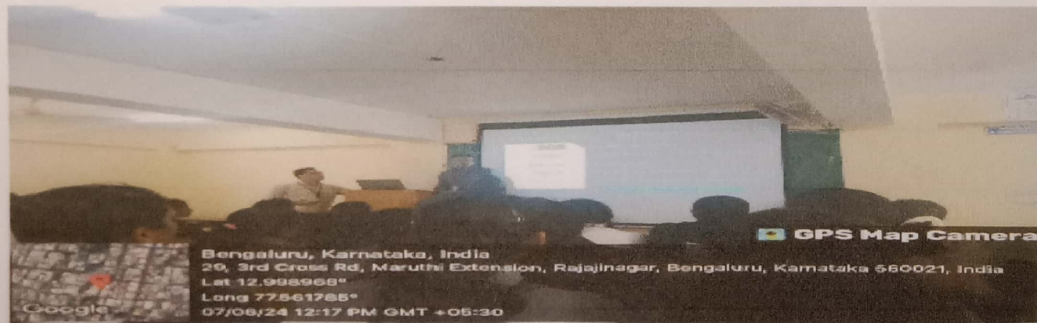
