The Principal, VCL informed the members that quotations have been called with the prior permission of Secretary, JES with regard to purchase of books to the library for the academic year 2023-24. Accordingly, 4 quotations were received from the following Publishers and Distributors and a comparative statement has been prepared and furnished herewith.

- a. M/s PREMIER BOOK HOUSE
- b. M/s LAW BOOK SHOP
- c. M/s MPP HOUSE
- d. M/s PANDITH BOOKS

a. Purchase of books to the library

The members perused the comparative statement and noted that M/s PREMIER BOOK HOUSE had quoted lowest rate of Rs.96,239/- for 82 titles and have also extended discount @ 23% on all titles.

The Principal informed the members that the aforementioned Publishers and Distributors were requested to take part in the negotiation process. Out of 4 Publishers and Distributors, only M/s PANDITH BOOKS took part in the negotiation.

The members noted that M/s PANDITH BOOKS had quoted Rs.98,228.25 for 80 titles besides extending varied discount. During the course of negotiation with Sri Prabhu, representative of M/s PANDITH BOOKS, he agreed to supply the books at a total cost of Rs.97,000/-. The members recommend placing order on them for supply books to the library at a total cost of Rs.97,000/-.

b. Renewal of subscription of Journals:

The Principal informed the committee that the subject of renewal of Journals was discussed in the Purchase Committee meeting held on 04.03.2024 and the Principal was directed to collect few more quotations in addition to one from M/s R.V. ASHIRWAD.

Accordingly, two more quotations were received from M/s MPP HOUSE and M/s PANDITH BOOKS. A comparative statement was prepared and the same is furnished.

The members perused the comparative statement and noted that M/s MPP HOUSE had quoted lowest rate of Rs.1,15,389/- for 10 journals followed by M/s R.V.ASHIRWAD (Rs.1,20,189) and M/s PANDITH BOOKS (Rs.1,21,475/-).

The Principal informed that M/s R.V.ASHIRWAD and M/s PANDITH BOOKS have come for negotiation. M/s R.V.ASHIRWAD during the course of negotiation agreed to renew subscription of 10 journals at

M/s PANDITH BOOKS during the course of negotiation agreed to renew subscription of 10 journals at a total cost of Rs.1,16,000/-. The members upon comparing the negotiated rates recommends placing order on M/s R.V.ASHIRWAD for renewal of subscription of 10 Journals at a negotiated cost of Rs.1,14,500/-.
